# Freegle Annual Financial Report and Accounts 6<sup>th</sup> April 2012 to 5<sup>th</sup> April 2013

We had income of £10,733 – mainly in donations. £6,788 of this was restricted for specific costs - £5,500 for making Freegle sustainable, £1,200 for media costs, £64 for the balance of the purchase of a laptop computer and £24 towards the fee to open a Virgin Money Giving (VMG) account. (note 4). The remaining £3,945 was unrestricted.

Expenditure was £3,084. The main costs are IT (£1,067), Media/publicity (£1,476) and Public Liability Insurance (£371).

This left us with £7,649, of which £5,500 is restricted to making Freegle sustainable. We had a surplus brought forward from last year of £714, so ended the year with £8,363 in the bank.
